Several community members' employment comes directly from federal grants – some fund critical health, bioscience, plus national security research projects; some help employ a significant network of direct service providers. Just a few weeks ago, over a quarter of the staff at Haskell Indian Nations University were terminated as part of the executive actions. These terminations have a particularly profound local impact on the already small team dedicated to providing Native American students their rights to a higher education, a right guaranteed to every one of those students by the federal government. Instead of a long-overdue updated federal farm bill, our Douglas County USDA Service Center had its office lease canceled and all NRCS technicians in our six-county region were fired last week. For those terminated, these reductions appear baseless - seeking out employees whose only 'deficiency' was that they were recently hired or reclassified to a different type of federal employee. There was no inquiry or analysis of the necessity or qualifications of these civil servants.
